- If your application is approved, we will inform you of the maximum amount you can claim in travel and accommodation expenses. This amount will not exceed AUD\$600.
- Please bear in mind that we can only reimburse you up to the amount of your grant, which may not cover the full cost of your travel and accommodation expenses.
- Payment will be made by cheque in your name only.
- You will need to supply tax invoices (receipts) for your travel and accommodation expenses before you can be reimbursed for the amount of your grant. **Please send your tax invoices, no later than 20 July 2010** to:
